### **The South Carolina Department of Health and Human Services – Project Leader**

The South Carolina Department of Health and Human Services (SCDHHS) is a cabinet agency of the South Carolina Governor's Office. The SCDHHS is the single state agency designated to administer the South Carolina Medicaid program, called Healthy Connections, under Title XIX of the Social Security Act. The agency is responsible for determining Healthy Connections Medicaid eligibility for all coverage groups and paying claims on behalf of its members. Nurse-Family Partnership is dedicated to improving the health and well-being of low-income, first-time parents and their children through its evidence-based public home visiting program. Nurse-Family Partnership is the most rigorously tested [maternal and early childhood health program](#) of its kind. Randomized, controlled trials conducted over more than 38 years demonstrate multi-generational outcomes that benefit society economically and reduce long-term social service expenditures.

The site also fabricates, assembles and installs systems for aft (rear) fuselage sections of the Boeing [787 Dreamliner](#) and joins and integrates midbody fuselage sections. Completed aft and midbody sections are delivered to final assembly in Everett, Wash., via Dreamlifter, or are moved across the campus to final assembly in North Charleston, S.C. Since 2009, Boeing has invested more than \$25 million with non-profit organizations throughout the state of South Carolina.

**Greenville First Steps:** Founded in 1999 by South Carolina state legislature, Greenville First Steps partners with local schools, early childhood educators, state agencies, churches, nonprofits, faith-based organizations, and businesses to promote school readiness initiatives by enhancing the work these agencies are doing in our community. Greenville First Steps, a 501(c)3 organization, is the only agency in Greenville County solely focused on improving school readiness outcomes for children aged 0-5.
